Page 9, line 4 and page 15, line 14 of the report mention a sauna which the Guardian believed to have been installed in the home by Sharon and Dorris Denney following its purchase. The Guardian's belief was based upon a statement by Sharon Denney that this had occurred. Ms. Denney, through counsel,



Guardian in its report regarding Dorris Denney's access to the


